This agreement is strictly confidential and is not transferable or assignable without prior written consent of MMI. Customer agrees that any change in liability for any debts incurred to MMI due to a change in customer's form of business, shall not be effective as to MMI, until MMI receives actual notice of the change by certified mail. The State of Maryland laws shall apply. Venue shall be in Prince Georges County, Landover, Maryland.
